

Funds and Mutual Aid to Support Indigenous Communities and Communities of Color

[ABQ Mutual Aid](#) is a coalition of local organizations and individuals working to protect our at-risk community members during the COVID-19 emergency in New Mexico.

[COVID Relief for Undocumented Families in New Mexico](#) will be getting monetary assistance directly to undocumented families in New Mexico as they need it during this crisis.

The [Far East Navajo COVID-19 Response Fund](#) in coordination with the Far Eastern Navajo chapters the Torreon Community Alliance request your support to help these communities respond to the COVID-19 pandemic. The funds would purchase critical sanitation supplies/ food supplies for the neediest of the communities. This project is meant to immediately supplement and support the local Navajo Governmental Chapters response and mitigation of the COVID-19 pandemic.

The [Navajo and Hopi COVID-19 Relief Fund](#) is an all-volunteer grassroots Indigenous led group operating on the Navajo and Hopi Reservations. They are prioritizing the elderly (especially those raising their grandchildren), single parents, and struggling families by helping them buy groceries, water, and health supplies, and by protecting them (and their vulnerable communities) from exposure by engaging volunteers to make the purchases and deliver them to a safe transfer location for the families.

In response to the COVID-19 crisis, the NB3 Foundation has created the [NB3 Foundation COVID-19 Response Fund](#). This donor driven fund will support two primary areas within Native American communities: access to nutritional food and clean water and access to education opportunities and youth development.

The [Native American Relief Fund](#) will provide emergency grants to organizations serving the state's hardest-hit communities. A number of funding partners have joined in this effort, including the New Mexico Foundation, Santa Fe Community Foundation, and Thornburg Foundation and champions such as Congresswoman Deb Haaland, State Secretary of Indian Affairs Lynn Trujillo, State House Representative Melanie Stansbury, and the New Mexico United soccer club.

NMW.O has established a [Gender Equity Emergency Fund](#). This Fund is aimed at supporting organizations and programs serving self-identifying women and girls, and particularly the needs of women and girls of color, women and girls in low income and rural communities, the LGBTQIA community, and the immigrant community, specifically for their emergency needs caused by COVID-19. As the only statewide women's fund focused on gender justice and healing, the Gender Equity Emergency Fund can help fill the gaps that might be missed by other emergency relief funds, or even by the federal assistance package.

In an effort to meet the most critical needs of the 20 Pueblo Nations during the COVID-19 crisis, the All Pueblo Council of Governors (APCG) and the Indian Pueblo Cultural Center (IPCC), have created and are administering a [Pueblo Relief Fund](#).

The [#ShareMyCheck Santa Fe](#) campaign has been launched by [Santa Fe Mutual Aid](#), along with coordinating organizations Earth Care/YUCCA/Poder Familiar, Red Nation, DSA-SF, SF Dreamers Project, Communities in Schools, Interfaith Leadership Alliance, Santa Fe Faith Network for Immigrant Justice, and Fathers New Mexico. The campaign is to encourage as many people as possible to redistribute all of, or part of, their stimulus check to a fund set up to redistribute these checks directly to those who won't be receiving a check. This fund is part of a network of rapid response mutual-aid funds and long-term grassroots movement building organizations under the umbrella of Santa Fe Mutual Aid.
